**Terms and Conditions**

**Tour price: \$7985 USD per person in a double room (2 people sharing).**

If you would like to have a single room you have to pay extra \$1985 USD.

- Deposit is only 800 USD during booking.
- Full payment is due two months before the tour.

**Price Includes:**

13 nights accommodation at 4-5\* hotels in India; three meals per day - breakfast, lunch and dinner - except the first arrival day (dinner only) and the last departure day (breakfast only); English speaking guides; Transfers in air-conditioned buses; Entrance tickets; All sightseeing tours; Reception at Delhi International airport; Airport Arrival & Departure transfers; Four domestic flights within India (Delhi - Varanasi; Varanasi - Khajuraho; Delhi - Aurangabad; Aurangabad – Delhi); Government taxes. Basic Health Insurance.

**Not included:**

International flight to/from Delhi in India; Indian Visa; Drinks during lunches and dinners.

Registration Form is a written agreement, which is concluded between travel agency *Archaeological Paths Grzegorz Poplawski* (hereinafter referred to as the 'Tour Organizer') and a tour guest (hereinafter referred to as the 'Traveler'). The agreement affects a tour organized by the Tour Organizer for the Traveler.

**Reservation and Payment:** The deposit of \$800.00 per person will be required at the time of booking. To insure your reservation, final payment will be due 60 days prior to the beginning of the tour. It is the responsibility of the Traveler (or Traveler's agent) to determine that final payment reaches the Tour Organizer on time. Payments are to be made by Credit Card or Bank Transfer. The credit card payments incur an additional fee of 3.9% for the bank operator that will be added to the Traveler's payment. For the bank transfer payment option any fees charged will be the responsibility of the Traveler.

**Cancellations and Refunds:** The deposit is fully refunded if the Tour Organizer cancels the trip for any reason. Otherwise, it is non-refundable. Traveler canceling prior to 60 days before the tour receives a full refund less a deposit. In case of cancellations made by Traveler from 60 days to 20 days prior to the tour, the amount refunded depends on the incurred expenses of the Tour Organizer (each case is decided individually on the basis of agreements and payments with the Tour Organizer's partners in India). The cancellations made by Traveler from 19 days prior to the tour until the first day of the tour are entirely non-refundable. No refund will be made for transfers, city tours or any other services (including meals, accommodations or transportation) voluntarily not taken. Tour Organizer reserves the right to cancel any tour prior to departure, in which case a full refund will be sent to the Traveler. Tour Organizer is not responsible for any costs incurred by Traveler (advance airline tickets and travel insurance). Any complaints and refund inquiries have to be made by Traveler within 30 days after the end of the tour. Complaints and refund inquiries will be considered by Tour Organizer within 30 days of the date of the inquiry. The complaints and refund inquiries sent in later than 30 days after the end of the tour will not be considered.

**Responsibility:** Tour Organizer is not responsible for any unpredictable situations like natural disasters, government actions, weather. Tour Organizer is not responsible for any personal accident like damage, loss, claim, cost or expense arising out of personal accident, or death, loss, damage or delay of baggage or other property. Tour Organizer reserves the right to make necessary changes in the tour itinerary. In the case of unexpected governmental actions or closure of any tourist attraction or site, Tour Organizer reserves the right to cancel the visit to a given site and in such event each cancelation will be replaced with another site/attraction.

**Health Insurance:** Tour Organizer purchases health insurance for Traveler in AXA Insurance Company. The Insurance purchased by Tour Organizer covers the insured amounts as specified below, not including chronic diseases or pre-existing conditions. There is a possibility to extend your health insurance policy – Traveler should contact Tour Organizer in order to extend health insurance coverage.
